Whereas, M/s Countrywide Promoters Private Limited had obtained a licence bearing no. 495-521 of 2006 for undertaking development of a residential plotted colony over an area measuring 73.79 acres in Sector 81, Faridabad ("Colony 1") and licence bearing no. 1172-1177 of 2006 for undertaking development of a residential plotted colony over an area measuring 51.1 acres in Sector 81, Faridabad ("Colony 2") (together the "Colony") in accordance with the provision of Director, Town & Country Planning, Haryana, Chandigarh ("DTCP").

And whereas, the Company under the Migration Policy dated 18.02.2016 of Town and Country Planning Department has proposed to migrate part of license no. 495-521 of 2006 and part of license no. 1172-1177 of 2006, granted for setting up Colony 1 and Colony 2 respectively, for taking license of affordable residential plotted colony under DDJAY 2016 over an area measuring 13.25 Acres in Sector-81, Faridabad.

And whereas, several individuals have made bookings/entered into purchase agreement for allotment of plot/property in Colony ("Allottees").

And whereas, the revised layout plan of Colony 1 and Colony 2 are being revised in accordance with the Letter of Intent "LOI" issued by DTCP, bearing memo no. LC-3995-JE(SK)/2019/6710 dated 07.03.2019, for setting up of an affordable residential plotted colony under DDJAY 2016 (after migrating part of area from Licence No. 495-521 of 2006 and part of area from License no. 1172-1177 of 2006 over an area measuring 13.25 Acres).

And whereas, the DTCP has required for seeking objections to the above stated migration from the Allottees of license colony of License no. 495-521 of 2006 and 1172-1177 of 2006 and accordingly vide this public notice objections are hereby invited from the Allottees for which a copy of the already approved revised layout plan of the Colony bearing drawing no. DGTCP 2584 dated 24.06.2011 and the proposed revised layout plan due to carving out of affordable residential plotted colony has been made available for perusal on the website of the Company www.bptp.com, at the office of Company at 28, ECE House, 1st floor, KG Marg, New Delhi, 110001 as well as in the office of District Town Planner (Planning), HSVP Complex, Sector-12, Faridabad.

Any Allottee having any objection in this regard, may file his objection in the office of District Town Planner (Planning), HSVP Complex, Sector-12, Faridabad or in the office of Company within 15 days of the publication of this notice, failing which it shall be assumed that there are no objections to the said migration.
