# Rabi crops face fury of rain, hailstorm in state; farmers seek special girdawari

Another spell expected in northern areas of state today, says expert

#### HISAR, MARCH 2

Massive hailstorm coupled with rain today caused extensive damage to standing rabi crops, especially mustard crops, that are at ripening stages in the state. The wheat crop too suffered damage as gusty winds have flattened the crops.

The farmers from several villages in Hisar, Bhiwani, Charkhi Dadri, Jind, Fatehabad districts reported damage to the mustard crops due to the hailstorm. Agriculture experts said the mustard flowers could not withstand impact of the hailstorm.

The India Meteorological Department said Rohtak received 47 mm rainfall. Sonepat 8.5 mm, Hisar 26 mm and Ambala 24 mm. Charkhi Dadri, Jind, Karnal Kurukshetra, Panipat, Fatehabad and Bhiwani districts also received rain coupled with

ty (HAU) Hisar, said low clouds due to Western Disturbances were the main cause behind the hailstorm in the plains.

He said rain would also likely to occur in northern areas of the state tomorrow. The climatic conditions would stabilise after tomorrow, he added. SONEPAT: Heavy rain accom-

# Khaps form 12-member panel to unite agitating farm groups

Condemning the state government's "repressive measures" against farm activists, khap panchayat leaders said such pressure tactics would not work. The also urged the Central government to accept farmers' demands. The meeting, presided over

by Sarv Jatia Daaran khap in Jind district's Palwa village, was attended by representatives of 55 khap panchayats and 25 farmers' organisations from various parts of Haryana. Azad Palwa of Daaran Khap said the khap leaders have taken an initiative to bring farmer organisations on one platform. He said the coordination committee has been tasked to meet a six-member committee of Samyukta Kisan Morcha (SKM) and organisations that were outside of the SKM, but part of the ongoing farm agitation.

"This committee will work to bring together all those groups for an efficient agitation. We also adopted resolutions to condemn the brute force used by the police on protesters who want to proceed to the national capital, demand release the arrested farmers as soon as possible and cancel cases registered against the farmers," Palwa said adding they also paid tributes to Shubhakaran Singh.

All the speakers unanimous ly stressed on the need for waging a fight unitedly on issues like law to ensure the MSP, loan waiver and other demands.

The khap meeting also criticised the government for issuing orders like cancelling passport of those participating in the agitation.

### Remarks against judicial officer: **HC** issues contempt notice

CHANDIGARH, MARCH 2

The Punjab and Haryana High Court has directed the issuance of a contempt notice to the petitioners before it and their counsel after taking of the scandalous remarks made in a petition against a judicial officer.

Justice Harpreet Singh Brar observed the pleadings of the petitioners indicated certain scandalous that remarks were made against the judicial officer without any justifiable cause. It was alleged that the judicial officer's integrity was highly questionable and doubtful and that he was engaged in granting unlawful favours to

It was also alleged that he indulged in corruption and the petitioners had been victimised by him. The officer had also acted under influence and had indulged in forgery and fabrication of evidence to pressure the petitioner to with-

draw the case. "It is trite law that the plea of mala fides has to be specific and demonstrable. Not only this, the person against whom the mala fides are alleged must be made a party to the proceedings and given a reasonable opportunity of hearing. Admittedly, the judicial officer concerned is not arrayed as party respondent in the present petition," the Bench observed. — TNS

# Joint panel formed to inspect illegal dyeing units fails to visit area

A special team has been formed to inspect the illegal denim dyeing units in the Kundli area of Sonepat district on the directions of the National Green Tribunal (NGT). Amid the ongoing farmers' protest and the sealing of the Singhu border near Kundli the joint team is yet to visit the area.

A Delhi-based environmentalist Varun Gulati had filed a complaint with the NGT in December alleging that over 500 dyeing units were operating in residential and nonconfirming areas in Faridabad, Sonepat, Gurugram and Jhajjar districts.

The dyeing units are categorised as 'Red Category'. Moreover, they do not have the necessary documents. including an NOC to operate here, the complainant alleged.

His complaint states that the illegal dyeing units were discharging untreated effluents directly to drains or open land which posed a serious health hazard to the people residing in nearby areas.

"There is no common effluent treatment plant in the area due to which the untreated effluent drains that ultimately flow into Yamuna," the complainant said. Following the complaint,

the NGT in its order on January 5 constituted a joint panel comprising a member from Central Pollution Control Board (CPCB), one from Haryana State Pollution Control Board (HSPCB) and an officer of District Magistrates of Sonepat, Faridabad, Gurugram and Jhajjar to take stock of the situation in all districts The next hearing on the matter is on April 5 and the committees have to submit their report by then.

"Following the NGT's direction, a joint team has been formed in Sonepat comprising Sonepat SDM (a member from the District Magistrate's office), RO Pradeep Kumar from HSPCB and Rishabh Kumar, Scientist-C of CPCB," said Pradeep Kumar.

The inspection was being delayed due to the law and order situation caused by the farmers' protest. The maximum portion of the area being inspected is in Kundli, Nathupur and adjoining areas, which is one of the worst affected areas due to which the member from the CPCB was unable to visit, he said. As soon as the situation normalises. the inspection would be carried out, the RO added.

# No departmental proceedings against minister, says coach

A woman coach, who has levelled molestation charges against state Minister of State for Printing and Stationery, Sandeep Singh, has alleged that no departmental proceedings, as envisaged in Vishakha Vs State of Rajasthan case decided by the apex court, have been initiated by constituting a committee as the case pertains to harassment of women at workplace.

In arguments submitted through her advocate for the framing of charges, she said specific evidence was collected by the prosecution which was reflected in the summary report under Section 173, CrPC, that after filing of the complaint, the accused had approached her through one Anil for compromise. She said he approached her through a WhatsApp call on January 5, 2023, with prosecution witness Raj Kumar Mittan, Secretary Athletics Haryana and Joint Secretary, Athletic Federation of

India, to compromise.

"The deposition of witness Raj Kumar Mittan is probably supported by the scientific evidence with regard to their telephonic conversation, unfortunately, the copy of the same is not supplied to the victim. It is a settled dictum of law that a victim of sexual offence case is an injured witness and her sole testimony is sufficient to convict an accused, but in the present case, there are testimonies of senior IPS and senior officials of the Sports Department which points out to the fact that immediately after the incident the victim/complainant had confided in them, who instead of encouraging her to fight for her rights, had asked her to ignore the incident," she said.

### old-age homes with modern facilities PRADEEP SHARMA 'PAY & STAY' CHANDIGARH, MARCH 2

The state government has unveiled a policy for setting up and managing state-of-the-art old-age homes with the aim of providing secure and comfortable living space to senior citizens to ensure their physical

and emotional well-being.

To be set up under the newly notified Samarth Vriddh SEWA Ashram Scheme, 2024, the old-age homes would have senior citizenfriendly amenities, including medical facilities, physical aids and assisted living devices, recreation facilities. spacious rooms/dormitories, security and adequate staff

for their well-being. A highlight will be the provision of food stuff containing average 1,700 calories per day, besides 50 gm protein to the residents. A provision of Rs 2,500 per month for food for every resident has been made

Govt launches policy for setting up

■ Senior citizens having annual income above ₹2 lakh will be able to avail the "pay & stay" facility at old-age homes

■Those above 80 years, persons having annual family income of up to ₹1.80 lakh and women to get preference in admission to old-age homes

Senior citizens to get food having 1,700 calories daily

■₹1,000 per month to be paid to every resident for routine expenses

in the policy. There is also a provision of Rs 1,000 every month to every resident for meeting daily expenses.

Under the new scheme, notified by the Social Justice, Empowerment, Welfare

of Scheduled Castes and Backward Class and Antyodaya (SEWA) Department, the old-age homes would be run both by the government non-governmental organisations (NGOs).

While the government agencies would run old-age homes with financial support from the government, the NGOs would be given a "maintenance grant" of Rs 6,500 per inmate per month.

On the admission criteria, the policy said the prospective residents would be selected by giving preference to the senior citizens above 80 years of age and indigent senior citizens whose family income was less than 1.80 lakh per annum. Female senior citizens would get preference over their male counterparts.

Meanwhile, facility of "pay & stay" would also available for senior citizens having annual income of 2 lakh and above.

#### As per the earlier approved building plan, EWS Block-1 has 120 EWS units having 20 EWS units on each floor from the ground floor to the fifth floor.
