

# AIADMK names nominees for 32 LS seats

Tamil Nadu's main opposition AIADMK on Thursday released its final list of 16 candidates for the Lok Sabha polls and also named its candidate for the lone Puducherry Parliamentary constituency. The AIADMK has completed the exercise of naming nominees and allotting seats to allies, and party chief Edappadi K Palaniswami is all set to launch his election campaign from Tiruchirappalli on March 24. In total, the AIADMK will contest in 32 segments and it has allotted seven constituencies to allies, the DMDK, Puthiya Tamizhagam and SDPI. Tamil Nadu has 39 Lok Sabha constituencies. For the Tirunelveli LS seat, Palaniswami announced Simla Muthuchozhan who was formerly with the DMK. She had unsuccessfully contested in 2016 against late AIADMK matriarch J Jayalalithaa from the RK Nagar Assembly constituency. Daughter-in-law of former DMK leader SP Sarguna Pandian, Muthuchozhan joined the AIADMK recently. An advocate, she is also the only woman candidate announced by the AIADMK



for the Lok Sabha polls. For the Vilavancode Assembly bypoll, the main opposition party has named a woman candidate. The ruling DMK, out of the 21 Lok Sabha seats, it is contesting, has given tickets to three women candidates. Kanimozhi (Thoothukudi), Tamizhachi Thangapandian (South Chennai) and Rani Sri Kumar (Tenkasi-Reserved). Palaniswami named G Premkumar, a medical doctor, as his party candidate

for Sriperumbudur and S Pasupathi, also a doctor for the Vellore seat. The ruling DMK has named veteran leader T R Baalu and Kathir Anand, son of top leader and Water Resources Minister Duraimurugan for Sriperumbudur and Vellore constituencies respectively. The AIADMK top leader named G Tamizhvendan and U Rani for Puducherry Lok Sabha seat and Vilavancode Assembly constituency respectively.

Bypoll to the Vilavancode segment in Kanniyakuram district will be held on April 19 alongside the Lok Sabha polls. The vacancy was caused due to the resignation of Vijayadharani, who joined the BJP after quitting her MLA post. Besides Sriperumbudur and Vellore, Palaniswami announced candidates for the Lok Sabha segments of Dharmapuri, Tiruvannamalai, Kallakurichi, Tirupur, Nilgiris (SC), Coimbatore, Pollachi, Tiruchirappalli, Perambalur, Mayiladuthurai, Sivaganga, Thoothukudi, Tirunelveli and Kanniyakuram. In the first list released on March 20, Palaniswami named nominees for 16 constituencies. It includes former MP Jayvardhan (Chennai south) and ex-MLA, Dr P Saravanan (Madurai). Tiruvallur (SC), Central Chennai, Cuddalore, Thanjavur and Virudhunagar are the five seats earmarked for the DMDK. Two other allies, the Puthiya Tamizhagam (Tenkasi) and SDPI (Dindigul) will fight one seat each. The All India Forward Bloc also supports the AIADMK alliance. Elections to 39 Lok Sabha seats in the state will be held on April 19.

# ISIS India head arrested: Assam Police

It was 15 days of meticulous analysis of intelligence inputs, scouting for local links, foolproof planning, raising a solid team and no-error execution that led to the arrest of ISIS India head from Assam, a senior police officer said on Thursday. The ISIS India head Haris Farooq alias Harish Ajmal Farukh and his associate Anurag Singh alias Rehan were arrested in Assam's Dhubri district on Wednesday after they had crossed over from Bangladesh. Addressing a press conference here, Assam Police's Special Task Force (STF) Inspector General Parthasarathi Mahanta, who led the entire operation, said the two dreaded ISIS cadres have already been handed over to the National Investigation Agency (NIA) for further legal action. "We got information from a central agency around 15 days back that there could be possible movement of top-rung ISIS leaders in certain parts of Dhubri. The input was credible and so the STF was involved," he added. The STF then started working on probable areas of movement, trying to find local links if any and prepared a plan accordingly to arrest them, Mahanta said. "By March 18, we narrowed down our

focus and we got very specific information on March 19 on their likely movement. We immediately rushed to Dhubri's Dharmasala. We saw two men walking on the road at around 4 am on March 20 looking for transportation to go to their destination," he added. The police already had the pictures of ISIS cadres and two of them matched with the men walking on the road, the IGP said. "We arrested them and immediately brought them to Guwahati. We handed them over to the NIA last night itself. The NIA will take them to Delhi and other places, where scores of cases are registered against the duo," he added. Assam DGP G P Singh termed the arrest as an outcome of the inter-agency synergy in the national effort to counter violent terrorism in the country. "Compliments to the team of officers involved in the operation," he said in a post on X. Without sharing details, Mahanta said interrogation of the two fundamental extremists are going on to find out their network, local contacts, funding source and information on explosives. "There are two parts of the investigation. If anything is found related to Assam, it will be taken care of by us. For the rest of India developments, the NIA will look into it.

"Assam has always been vulnerable and we have been alert constantly. That is the reason we could arrest them immediately when they entered India from a neighbouring country," Mahanta said. Another senior official, who did not wish to be named, said both the ISIS cadres are wanted in the NIA case related to the Delhi module, covering

incidents in Delhi, Mumbai and Lucknow. "The last date of the stipulated period of filing the charge sheet in the Delhi module case is tomorrow and if they were not found, the NIA would have to declare them absconding and file the charge sheet accordingly. So, it is a big success for the security agencies," he added.
